I. COURSE DESCRIPTION

This course is designed for students enrolled in the B. A. in English program with the elective track in translation. It is the fifth course and focuses on offering students a general outlook as to how to manage the translation of legal, financial, and official documents based on their characteristics. This course emphasizes the application of the Skopos theory as a translation model that guides the decision process for such texts. Mediación Virtual will be the official platform for submitting documents, presentations, videos, and evaluations.

II. GENERAL OBJECTIVE

By the end of the course, students will be able to produce high-quality legal, financial, and official translations by identifying their main characteristics, purpose, audience, and context.

III. SPECIFIC OBJECTIVES

By the end of this course, the student will be able to:

- A. Recognize the difference between common law and civil law.
- B. Demonstrate a basic understanding of the Costa Rican legal system.
- C. Distinguish between different legal and financial documents.
- D. Apply the appropriate research and format techniques for translating legal and financial documents.
- E. Identify the difference between legal, official, and court-related translation.
- F. Define basic concepts related to economy, finances, and trade.
- G. Identifying the characteristics of official translation.
- H. Follow the appropriate format for official translations.
- I. Analyze the translation process for legal, financial, and official documents.
- J. Determine the translators' professional and ethical responsibilities when translating legal, financial, and official documents.

V. METHODOLOGY

During the first semester of 2025, this course will be 100% face-to-face. Mediación Virtual is the main platform that will be used for uploading course materials, presentations, and videos. Mediación Virtual is also **the official platform to submit all the evaluations of the course**, unless otherwise indicated by the professor.

Classes will last three hours per week. During class, students will review and analyze both theoretical and practical aspects of translation simultaneously, focusing on the active participation of students and guidance from the instructor. Students will have six hours a week for independent out-of-class work to complete the tasks specified in the calendar of activities.

Activities will include proposing ideas related to the topic, analyzing translation instructions and parallel texts, and reading comprehension, terminology and theory-related exercises. Besides, students will identify translation problems, find solutions, and analyze the strategies used and proposed solutions.

Readings and exercises will be assigned for class discussion and analysis. Students should work on them (individually, in pairs or small groups) to find appropriate solutions to the different translation problems. Students are expected to discuss the challenges they faced, propose solutions, and comment on the solutions proposed by other students.

This course emphasizes the application of Skopos Theory as a theoretical model of translation. In addition, the course will focus on translation as a process that accounts for the different types of

relationships operating between the source text (ST) and target text (TT), and the criteria used by translators to make their decisions.

VI. EVALUATION

Components:

One out-of-class evaluation ²	25%

- 1. In-class translations will occur within the class time established. Each one is worth 15%.
- 2. Out-of-class evaluation will include the translation of a text (15%) and an analysis of it, based on the studied theory (10%).
- 3. Assignments may include any of the topics of the course, and they will be announced at least one week before.
- 4. The final project will be done in groups and in different stages. The project will include four stages: presentation of a fictional translation company, a negotiation, a translation, and an oral presentation in class.
- 5. They must follow the instructions provided by the professor and present their analysis in front of the class.

VII. OBSERVATIONS

- A. No assignment will be accepted after the due date.
- B. The use of Google Translate or any other automatic translation resource in the evaluations will annul the points obtained, since the students would be presenting intellectual material that is not their own.
- C. The students will be bound by the *Reglamentos de Evaluación* de la Universidad de Costa Rica.
- D. Plagiarism is unacceptable and will be punished according to *Reglamento de Orden y Disciplina de los Estudiantes de la UCR (Artículos 4-20).*
